### Conditions of Registration

1. The unit shall strictly comply with the Provisions of the Plastic Waste Management Rules, 2016 as amended in 2021 notified under the Environment (Protection) Act, 1986.
2. The industry shall manufacture of above said products by using raw material as mentioned above.
3. This Registration shall be in force subject to valid Consent under the **Water (Prevention and Control of Pollution) Act, 1974** as amended and the **Air (Prevention and Control of Pollution) Act, 1981** as amended, and authorization under the **Hazardous Waste (Management, Handling and Transboundary Movement) Rules 2016 as amended 2021**.
4. Every recycler/producers/manufacture shall maintain a record of details of the person engaged in supply of Plastic waste.
5. This registration shall also deem expired in case of expiry or suspension or cancellation of any of the existing consent and authorization. If applicable issued by Uttarakhand Pollution Control Board and shall remain invalid till consent/authorization are obtained.
6. The manufacturer/recycler/producer shall be responsible to ensure that the quantity of the raw material produced each time is recorded in the Log-Book.
7. The registration shall be produced at the time of inspection upon request of an Officer authorized by **Ministry of Environment and Forests, Government of India, Central Pollution Control Board and Uttarakhand Pollution Control Board**.
8. The manufacturer/recycler/producer shall not rent/lend/sell/transfer this registration certificate.
9. Any change in the manufacturing/recycling/producing technology, as given in the application shall not be carried out with prior permission of this Board.
10. Application in triplicate for renewal of registration shall be made well in advance at least 120 days before expiry, in respective form of the Plastic Waste (Management and Handling Rules, 2016).
11. At the time of submission of the application for renewal of registration, the unit should submit a copy of the log book along with details of the quantity of products(s) period of registration, and a statement showing point wise compliance status of the above conditions. This information should be supported with Central Excise/sales tax details.
12. The registration may be cancelled or suspended by this Board in case the unit fails to comply with any of the conditions of the registration or with any of the provisions of the Environment (Protection) Act, 1986 as amended and rules made there under.
13. In addition to above, UKPCB may stipulate further conditions, if so required, in interest of environment protection.

14. Unit should comply rule no. 8 as "Responsibility of Waste Generator" and rule no. 11 as "Marking or Level" of Plastic Waste Management Rules, 2016 as amended in 2021.
15. Unit should strictly comply the Notification of Government of Uttarakhand dated 16.02.2021 and MoEF&CC Notification dated 12.08.2021 regarding restriction and prohibition on plastic.
16. The industry shall ensure that the product made by it is not utilized directly in the market and is sold only to the industries called convertors who utilize their product as raw material for converting into multi-layered plastics/packaging before being sold to the brand owners. The industry shall submit quarterly report in this regard to the concerned Regional Office.
17. The industry shall sell its material as raw material only to such PIBos having valid authorization under the Plastic Waste Management Rules, 2016 as Amended in 2021 from SPCB/CPCB as the case may be.
